49th ART EXHIBITION CONDITIONS

1. ENTRY:

- Two paintings may be entered per section.
- All paintings for which prizes are awarded are non acquisitive.
- Entry fees are **\$15.00** per painting for non-members, **\$10.00** per painting for CRAS members.
- Payment by cheque or money order payable to City of Ryde Art Society.
- Send your entry form and payment to arrive no later than **1st September 2009** to -

2. ARTIST'S WORK

- Artwork entered must be the original work of the artist, completed within the 12 months prior to the exhibition. Known copies of other artworks will not be accepted.

3. SIZE:

- For Section 7, the maximum frame perimeter allowed is 60 inches (153 cm).
- Entries in other sections must not exceed a maximum frame perimeter of 140 inches (355 cm).
- In only one section, you may include one larger painting, with a max. perimeter 168 inches (427 cm).

4. FRAMING:

- All entries must be correctly framed and ready for hanging. No screw eyes or projections, please.
- Wet paintings **will not be accepted**.
- Please complete the labels provided with the entry form and attach to the back of each painting.
- Please PRINT your name, address, telephone number, price, title and section.

5. PUBLICITY:

- The exhibition committee reserves the right to reproduce any works for this exhibition in the print or electronic media.

6. Sales & Commission:

- All works must be for sale.
- A commission of 25% for non-members, 20% for members of CRAS, will be deducted from the sale price of all works sold.

7. DELIVERY:

- Paintings must be delivered to –

- On **MONDAY 14th SEPTEMBER 2009** between **10am – 7 pm**.
- Courier services, if required, are available from Artcare Courier Service, phone 02 4655 7473.
- Do **not** post mail or paintings to this address – timely delivery is unlikely.

8. INSURANCE:

- Exhibitors must arrange their own insurance.
- All reasonable care will be taken, but no responsibility will be taken for loss or damage to paintings whilst in the custody of the exhibition committee.

9. JUDGING:

- All entries will be viewed by the judge, but only those selected for hanging will be displayed.
- The decisions of the judge will not be altered and no correspondence will be entered into regarding these decisions.

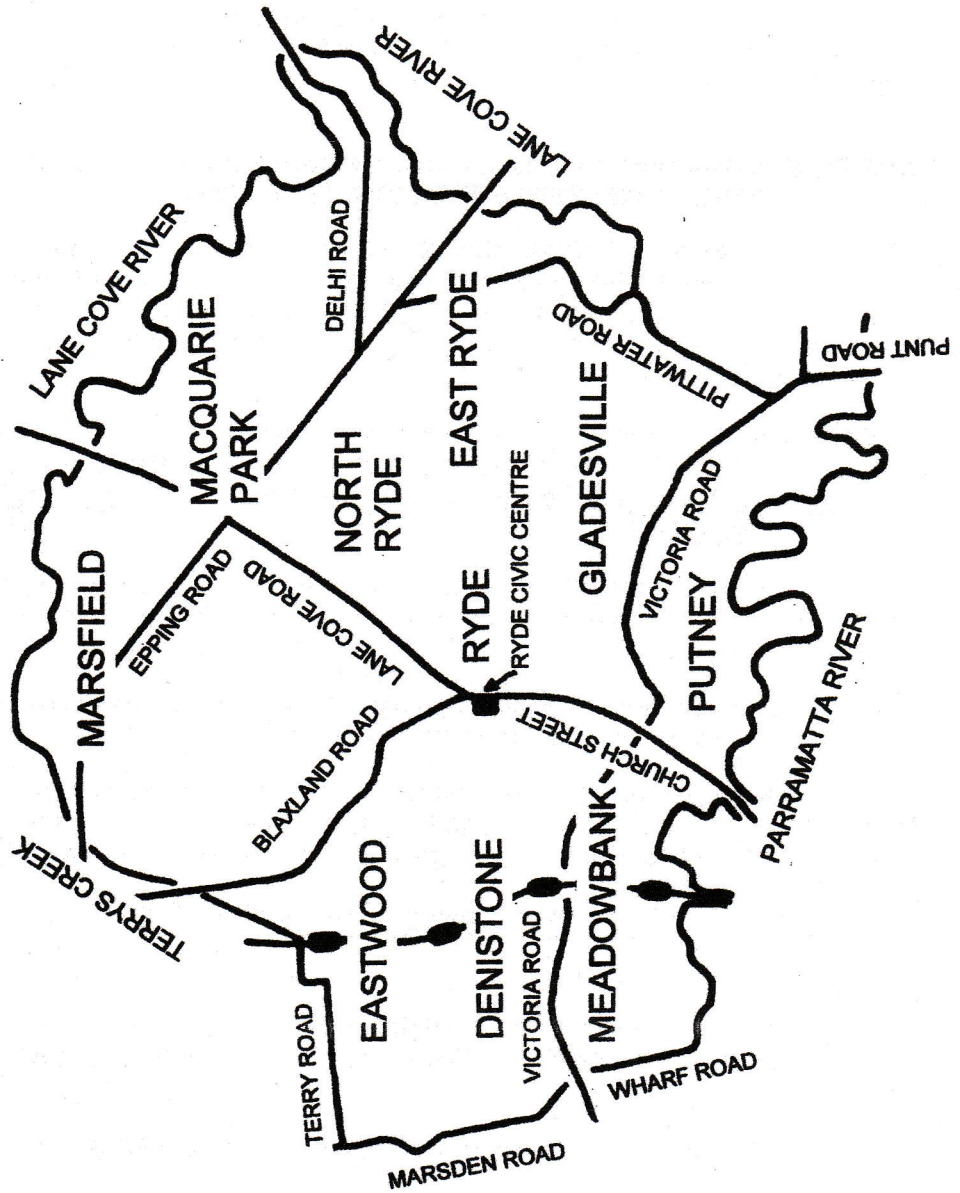
10. COLLECTION:

- Paintings not selected, or listed in the exhibition catalogue may be collected at any time when the exhibition is open.
- All paintings, accepted and hung, including those sold, may not be removed from the exhibition until **Saturday 26th September 2009**, between **9am – 11 am**.
- Uncollected paintings will be taken to Willandra Art Centre, 707 Victoria Rd, Ryde, and may be collected on payment of a fee of **\$20 per painting**.
